Notice of Approvals at Ordinary General Meetings of Shareholders for Share Transfer Plan to Establish Joint Holding Company of Maeda Corporation, Maeda Road Construction Co., Ltd., and Maeda Seisakusho Co., Ltd. (Joint Share Transfer)

The share transfer plan (the "Share Transfer Plan") to establish INFRONEER Holdings Inc. as the wholly owning parent company (the "Joint Holding Company") of Maeda Corporation ("Maeda Corporation"), Maeda Road Construction Co., Ltd. ("Maeda Road"), and Maeda Seisakusho Co., Ltd. ("Maeda Seisakusho"; and Maeda Corporation, Maeda Road, and Maeda Seisakusho are collectively referred to as the "Three Companies") by means of a joint share transfer (the "Share Transfer") as of October 1, 2021 (scheduled) was approved at the respective ordinary general meetings of shareholders of the Three Companies as in the following: the 76th Ordinary General Meeting of Shareholders of Maeda Road held on June 25, 2021 and the 71st Ordinary General Meeting of Shareholders of Maeda Seisakusho held on June 22, 2021.
